Dear Penny Rankin,

Thank you for your correspondence to the Right Honourable Prime Minister Carney, dated October 10, 2025, regarding budget reductions to Women and Gender Equality Canada (WAGE). His office shared your letter with mine. I appreciate your engagement and the thoughtful concerns that you shared.

Our government remains committed to building an economy that works for everyone. Gender equality is not only a matter of fairness – it is foundational to Canada's resilience, prosperity, and unity. Ensuring that women, gender-diverse persons, and 2SLGBTQI+ communities can fully participate in and benefit from Canada's progress is critical to meeting the today's challenges and securing a better future for all.

Through [Budget 2025](#), we announced new, stable and ongoing funding to WAGE. We are investing \$660.5 million over five years and \$132.1 million ongoing to ensure sustained progress toward equality and safety for women, girls, and 2SLGBTQI+ people. These new investments include:

- \$382.5 million over five years, starting in 2026-27, with \$76.5 million ongoing to Advancing Women's Equality;
- \$54.6 million over five years, starting in 2026-27, with \$10.9 million ongoing, to support 2SLGBTQI+ communities. This includes \$7.5 million over five years, with \$1.5 million ongoing, for Pride Security; and,
- \$223.4 million over five years, starting in 2026-27, with \$44.7 million ongoing, to strengthen federal action in response to gender-based violence in support for specific populations who have experienced such violence. This includes Indigenous women and underserved populations. This investment will also enable ongoing funding for crisis hotlines.

Budget 2025 also reaffirms our government's commitment to continue working with provinces and territories to end gender-based violence—including through existing bilateral agreements that enable jurisdictions to fund essential prevention services and direct support for survivors.
